- A. For Posts on Serial No. 1 – Employees of Department of Post in Level 4 are only eligible.
- B. For Posts on Serial No 2 – Employees of Department of Post are not eligible.

5. PAY AND ALLOWANCES

An officer/employee appointed on deputation/foreign service may elect to draw either the pay in the scale of pay of the deputation/foreign service post or his/her basic pay in the parent cadre plus deputation allowance thereon, plus personal pay, if any.

6. TENURE OF DEPUTATION

- a) The tenure of deputation shall be for one (1) year which may be reviewed for extension on year-to-year basis for another period of 02 years, subject to satisfactory performance if required, as per the Bank's business requirements and in the exigencies of public services and the candidates shall not be eligible for regular absorption in IPPB.
- b) Business performance shall be reviewed every six months. In case performance is found dis- satisfactory over two consecutive reviews, the engaged officer may be repatriated after serving one- month notice.
- c) There shall be a mandatory 'cooling off' period of two years after every period of deputation of employees/officers in IPPB. Therefore, officer who were engaged with IPPB at any post in the past, shall be eligible to apply under this recruitment exercise only, if they are not in the mandatory 'cooling off' period.

7. SELECTION PROCEDURE

- a) Merit list will be drawn banking outlet wise. Selection will be made on the basis of percentage of marks obtained in the graduation. However, the Bank reserves the right to conduct Assessment/Online Test/Group Discussion/Interview.
- b) In case of equal graduation percentage obtained by two candidates in the merit list the candidate will be selected basis the earlier date of birth.
- c) Candidate shall fill exact percentage of marks obtained in the Graduation up to two places of decimal. The percentage marks shall be arrived at by dividing the marks obtained by the candidate in all the subjects in all semester(s)/year(s) by aggregate maximum marks in all the subjects irrespective of honors / optional / additional optional subject, if any. This will be applicable for those Universities also where Class / Grade is decided on basis of Honors marks only. Rounding of percentage will not be acceptable under any circumstances.
- d) Wherever percentage (%) of marks is not awarded by the Board/ University/ Institute and only grades (e.g. GPA /CGPA/CQPI) are awarded, the same should be converted to the exact equivalent percentage (%) of marks as per the formula provided by the college/university. If any deviation is found in the application form with respect to the percentage of marks, such applications will be summarily rejected.
- e) It is mandatory to upload the “No objection Certificate” (NOC) from your parent organization at the time of applying. The NOC should clearly contain-
 - i. Statement giving details of Major/Minor penalties, imposed upon the Employee, if any during the last five (5) years.
 - ii. Vigilance Clearance Certificate from the Competent authority.
 - iii. Relieving condition “the in case of selection the employee shall be relieved within **30** days.
- f) In case of NOC where the conditions as stipulated in point (e) if found absent the application will be rejected at the Merit preparation stage without intimation.
- g) The deputation with IPPB shall commence only after completion of mandatory formalities pertaining to their relieving process as stipulated by their parent organization.
- h) Merely satisfying the eligibility norms do not entitle a candidate to be in the select list.
- i) Results of the candidates who have qualified for various stages of the recruitment process and the list of candidates finally selected will be published on the website.

8. APPLICATION FEE

Application Fee of ₹ 750/- (Non-Refundable) is payable. Candidates should ensure their eligibility before paying the fees/applying online. Application once made will not be allowed to be withdrawn and fee once paid will NOT be refunded under any circumstances nor can it be held in reserve for any other future selection process.

10. OTHER TERMS & CONDITIONS

a) Term of deputation-

The deputation shall be governed by the standard term and condition as prescribed by the bank from time to time.

b) Leave, pension and other benefits

Leave, pension, gratuity and other benefits will be regulated as per rules of the parent department. No deputation allowance or additional financial benefits will be admissible beyond those permitted under extent instruction.

c) Performance and Conduct-

The performance of the deputed official shall be subject to periodic review. unsatisfactory performance or misconduct may lead to premature repatriation.

d) Travel and Joining: -

TA/DA for joining on repatriation will be as per the rules of the borrowing organization or an admissible under deputation terms.

e) Application Procedure-

Application must be submitted with all the complete details and the documents as specified.

f) The borrowing organization reserved the right to cancel or modify the terms and condition of deputation at any stage before onboarding without assigning the reason.

Any other terms and conditions pertaining to deputation of employees/officer shall be governed by the guidelines of the deputation policy the Bank in this regard from time to time.

11. ACTION AGAINST CANDIDATES FOUND GUILTY OF MISCONDUCT:

If a candidate is (or has been) found guilty of:

- ii. Impersonating or procuring impersonation by any person, or
- iii. Resorting to any irregular or improper means in connection with his/her candidature, including resorting to canvassing for his candidature, or obtaining support for his/her candidature, by any means, such candidate may, in addition to rendering himself/herself liable to criminal prosecution, shall also be liable:
 - (a) To be disqualified from the selection process for which he / she is a candidate;
 - (b) To be debarred, either permanently or for a specified period, from any examination or recruitment conducted by IPPB.
